    - i. The Council reflected on the hearing as a whole. The Council felt that it went well for a first time and overall the Council felt deliberating publicly was hard, but that it is required due to the Stanley Act, that the Council has to follow, due to being under the ASI Board. The Council feels in the future that more visuals would be helpful.

      2. Complaint 3: The Chair will reach out to the complainant and let them know that the issue has been resolved by asking housing to take down the flyer. The complaint did not accuse anyone of wrongdoing.
