 - a. It was a great outlet for reaching more students
 2. Questions that were asked at the event:
 - a. I felt there were a bit too many questions about how the Candidates would manage their time and I suggest for future councils to have more generic time questions
 - ii. I. Campos:
 1. Felt that people, who were just there for lunch and not there for the event, got into it as the event went out. Made a good location to reach different types of students.
 - iii. J. Morecraft:
 1. It would be nice if next year there could be a larger group of Student Government members in attendance, since they ask great questions.
 - iv. I. Campos:

 - v. E. Heim:
 1. If there is an opportunity to allow in the future for avenues for students to ask candidates unanswered questions they have, they would be a good idead

- vi. I. Campos:
 - 1. It would be nice to allow the candidates to have the opportunity to say a closing statement at the end of the event.

 - ii. I. Campos:

 - 3. Utilize Ekho even more to promote Elections and voting
