- 6) Reports:
  - a. Student Government (A. Fox)
    - i. The focus for Student Government currently is on supporting students during challenging times, including the student protest for Palestine that took place over the summer.
    - ii. Student Government is currently reviewing the campus financials, including work related to endowments, to ensure proper allocation of resources.
    - iii. Elections are coming to a close, and new candidates will be announced very soon.
  - b. Student Programming Board (K. Barillas)
    - i. The "Wicked Lights Camera Bingo" event featured prizes for bingo winners and around 50 attendees attended!
    - ii. A special board meeting was held for event volunteers, where pizza was provided as a thank-you for their support.
    - iii. At the Foodie Tuesday event, a total of 250 tickets were distributed.
    - iv. The "Together We Craft" event, which included bouquet and scrub-making activities, was well-attended with 50 participants.

- v. A 90s-themed scavenger hunt will be held, with prizes awarded to the winners.
- c. Student Union (T. Obispo)
  - i. The Student Union is preparing for an upcoming book giveaway event on Wednesday April 2nd.
  - ii. "Coffee and Convo" sessions are being organized to encourage informal discussions among students and staff on April 9<sup>th</sup> and May 8<sup>th</sup>.
  - iii. The Student Union is partnering with SPB for the "Together We Craft" event to further engage students in creative activities happening on April 15th.
  - iv. A "Grocery Plinko" event will also take place as part of an ongoing series of student activities happening on April 22nd.
- d. The CI View (A. Monge)
  - i. The CI View is focused on preparing for the upcoming elections and ensuring fairness by providing a platform for all candidates to share their views.
  - ii. In addition, promotion for the graduation gallery is underway to showcase student achievements.

  - iii. It was noted that any change in the ASI fee will require a referendum, so increases are not guaranteed.

    - i. An overview was provided of the updated enrollment projections, reflecting the most recent data available for the upcoming academic years.
    - ii. A snapshot of current ASI fee revenue projections against projected expenses was discussed.

- iii. Given the declines in enrollment, the need for budget reductions is most likely and will be explored with the BASC. Cuts would impact budget allocations moving forward.
- iv. The student union fee projections for the next few fiscal years were also discussed, and it was confirmed that the student union remains in a better financial position but will need to consider reductions as well.
