 - vi. Sociology Club is event on campus? Club did not respond. Russ confirmed event is on campus.
 - vii. Spectrum clarify budget for awards and gifts. 2 events one speaker per event. 1 gift for each speaker would be \$100 and not the requested \$150. \$50 cut from this budget.
 - viii. Adelante Mujer club did not respond to inquiry so original request was used. Russ will be meeting with the club. Based on the large amount for food, \$2000 for food was placed in priority B and \$400 in priority A. \$600 was cut due to submission errors.
 - ix. Generation Action Left as is because the errors were still there even after club was given second opportunity to correct the submission errors.
 - x. Pre American Medical Student Association Club was given second opportunity to correct errors but their second submission corrected the issues. \$20 is not approved.
