- 5) Public Forum: None
- 6) Reports:
  - a. Student Government (E. Conde)
    - i. Senate meetings will be commencing this year.
    - ii. Student Government is actively exploring ways to strengthen collaboration with registered student clubs and organizations. This includes brainstorming engagement opportunities and future partnerships that support student involvement and leadership development.
    - iii. The team is continuing to provide support and mentorship for current student senators, ensuring they have the tools and guidance needed to succeed in their roles throughout the academic year.
  - b. Student Programming Board (C. Gil)
    - SPB hosted *The Bash* earlier this year on August 27 as one of their welcome week events. The event saw strong attendance with approximately 235 students participating.
    - ii. SPB held *Mercadito y Los Gritos*, a cultural celebration event, which brought in 456 attendees and featured music, activities, and community engagement.

- iii. SPB is preparing for *Trivia Throwdown*, scheduled to take place during the *Late Night Eats* event on September 18.
- iv. SPB will be hosting *Together We Craft: Vision Boards* on September 30, giving students a creative space to reflect and set personal goals for the semester.

#### c. Student Union (A.J. Antonio)

- i. The Student Union team successfully completed its employee training to kick off the semester.
- ii. The current Student Union team consists of 10 student staff members supporting daily operations and events.
- iii. The Student Union recently wrapped up its *Sunshine Social Series*, which brought in a total of 537 check-ins over four days, including over 200 check-ins in a single day.
- iv. *Rock Your Crocs*, a themed mini-event during *Late Night at the Student Union*, had 30 student check-ins on September 10.
- v. The Student Union will host a *Heritage Month Kickoff* event on September 15 at the Student Union Information Desk.
- vi. Grocery Plinko is scheduled for September 23 at the Student Union Info Desk.
- vii. As part of recent engagement efforts, the Student Union partnered with CI Dining to distribute 20 food vouchers to students as event giveaways.

## d. The CI View (T. Walker)

- i. The CI View currently has five student staff members on the team and one intern supporting the team this semester.
- e. Community Report: (K. Robinson)
  - i. Ventura College is celebrating its 100th anniversary, and Oxnard College is marking 50 years; both colleges are hosting celebratory events throughout the academic year.
  - ii. The Club Rush + Student Services Fair will be held on September 16–17, featuring ~50 clubs and 15 student services; students can earn a free food ticket by engaging with at least two clubs and one service.
  - iii. Latinx Heritage Month events are being hosted at Moorpark College, including a Mexican Independence Day celebration on September 16 and a Lunch & Learn with author Aura Marquez on September 30.
  - iv. Oxnard College's housing partnership with CSUCI has expanded, with 13 OC students currently living in CSUCI student housing, up from 10 last year.
  - v. There is growing concern over the potential loss of HSI designation and federal funding due to a legal challenge; all three colleges in VCCCD rely on this support to serve their high Hispanic/Latine student populations.
