  - a. INFORMATION ITEM: Council Introductions (L. Garcia)
    - i. The Council introduced themselves to each other.
      1. Griffin Giboney served on the ASI Election Council last year and is the only returning member of the Council for this year.
    - ii. A. Block-Weiss: Shared their role for the Council is to be their go to professional staff support person.
  - b. DISCUSSION ITEM: Purpose and Expectations of the ASI Election Council (L. Garcia)
    - i. L. Garcia: The Council supports and runs the full election process for ASI Student Government and ASI Board positions. This includes promoting the process for officers applying to run and getting students to vote. Council members are expected to be on time and follow through with assigned tasks. Finally, the Council ensures the Code is upheld throughout the election process.

- g. DISCUSSION ITEM: Marketing Ideas for Campaign One (Run for Office) (A. Block-Weiss/L. Garcia)
    - i. The Council liked last year's marketing (specifically the famous figures and alumni pieces) and the color scheme and believe that A-frames, digital screens, and postcards to hand out are great ways to reach students.
    - ii. The Council suggested it might be good to add to the alumni campaign with more recent alumni.
    - iii. Larry Garcia and Annie Block-Weiss will correspond with Kristina Hamilton as the ASI Graphic Designer and then submit a design request for the "Run for office" campaign by Jan. 24, 2022.
  - h. INFORMATIONAL: ASI Election Council Budget (A. Block-Weiss)
    - i. The Council's budget is \$4180 for this year.
      - 1. This will cover marketing print cost, two voting events, and possible giveaway items.
