- 7) New Business:
  - a. INFORMATIONAL ITEM: Candidates Update (A. Block-Weiss)
    - i. A. Block-Weiss shared with the Council the number of candidates running for office. Candidate still must attend a required candidate workshop this week to be eligible to run and begin campaigning on Monday at 8am. Names will be shared with the Council at next weeks meeting, when the information is public.
  - b. DISCUSSION ITEM: Required Candidate Workshop Debrief/Prep (J. Morecraft)
    - i. Candidates seemed overall very excited and enthusiastic about running for office!
    - ii. At one of the required candidate workshops a candidate asked about the use of a dolphin image in terms of the logo policy in the ASI Election Code.
      - The code states: "Logos: To avoid the perception of organizational endorsement, placement of the ASI logo, Student Union logo, ASI entity logos, or CI logos (including but not limited to the formal CI logo, CI spirit logo, and University seal) on campaign materials is not permitted."
        - a. The Council discussed the question and decided that it is ok if they use a generic dolphin in their campaign materials, and just to be aware not to use the CI mascot, Ekho or the outline of a dolphin which is in the CI logo. A. Block-Weiss will email all the candidates to share this information and include the images of the CI dolphins, so the candidates know not to use those specific dolphins.
  - c. DISCUSSION ITEM: Campaigning (J. Morecraft)
    - J. Morecraft reminded the Council that campaigning will begin Monday, March 29 at 8am and end Wednesday, April 14 at 5pm. Additionally shared that the Council may get questions about the Code throughout the campaign period.

- d. DISCUSSION ITEM: Social Media Plan for Voting Campaign (J. Morecraft)
  - i. The Council will recreate the social media plan to schedule out the social media for the voting period.
- e. DISCUSSION ITEM: I Voted Sticker Giveaways (J, Morecraft)
  - i. There will be an "I Voted" sticker at the end of the ballot, which they can they post to their IG story and tag ASI to be entered in the giveaway.
